Section 4. First Aid Measures

Eyes: Flush eyes immediately with running water at low pressure for 15 minutes. Consult an ophthalmologist.

Skin Contact: Take off immediately all contaminated clothing. Get medical attention if irritation develops and persists. Wash skin thoroughly with soap and water for several minutes

Special Fire-Fighting Procedure: Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA.
